WESTERN REGIONAL WATER COMMISSION DRAFT MINUTES

Thursday, May 21, 2020

The Western Regional Water Commission ("WRWC") Board of Trustees held a regular meeting on Thursday, May 21, 2020, via Teleconference, and conducted the following business.

1. Roll Call and Determination of Presence of a Quorum

Chair Hartung called the meeting to order at 1:30 p.m. There was a quorum present via telephonic and/or Zoom meeting participation.

4. Approval of Agenda (For Possible Action)

COMMISSIONER DAHIR MADE A MOTION TO APPROVE THE AGENDA, SECONDED BY COMMISSIONER DUERR. THE MOTION CARRIED UNANIMOUSLY WITH SIX (6) COMMISSIONERS PRESENT.

5. Approval of the Minutes for the WRWC meetings of January 15, 2020 and February 19, 2020 (For Possible Action)

COMMISSIONER AINSWORTH MADE A MOTION TO APPROVE THE MINUTES, SECONDED BY COMMISSIONER DUERR. THE MOTION CARRIED UNANIMOUSLY WITH SIX (6) COMMISSIONERS PRESENT.

6. Report on the Northern Nevada Water Planning Commission (NNWPC) recommendations on annual priorities for ongoing and future projects and studies for Fiscal Year 2020 – 2021; and possible direction to staff – Chris Wessel, WRWC Water

Management Planner and Jim Smitherman, WRWC Water Resources Program Manager. (For Possible Action)

On November 6, 2019, the NNWPC conducted its annual workshop to develop a prioritized list of identified projects and topics for Fiscal Year ("FY") 2020-2021. Historically, the outcome of the workshop has been used as the basis for development of the professional services portion of the WRWC tentative budget. The professional services budget worksheet details priority topics to be addressed by projects funded fully, or in part, by the Regional Water Management Fund ("RWMF"). Staff recommends that the WRWC review and discuss recommendations from the NNWPC and approve, with or without changes, the recommended priorities for the upcoming year.

Chris Wessel, WRWC Water Management Planner, explained for Commissioner Brekhus he does not have a record of which NNWPC commissioners voted for each project as individual roll call votes were not taken on a project by project basis. He also confirmed there is a feasibility study being done on the Long Valley Creek project.

Jim Smitherman, WRWC Water Resources Program Manager, stated we have a contractor working on a permitting feasibility analysis for discharge to Long Valley Creek in California. He confirmed for Commissioner Brekhus that the NNWPC voted to approve the contract for the feasibility analysis.

Commissioner Brekhus stated if the feasibility analysis is contemplating that some of the effluent is coming from the Reno Stead Plant, that is not the direction of the Reno City Council. Reno City Council said they would not be exploring sending effluent to Long Valley. She asked when the study will be done and stated she would like a copy of the scope of the contract.

Mr. Smitherman explained that the project is on a backburner at this time, as we are collecting water quality data from Long Valley Creek. He confirmed that City of Reno staff are not participating in this. He also explained the feasibility contemplates discharge not only from the Reno Stead Water Reclamation Facility but also from the County's Cold Springs Facility.

Commissioner Brekhus stated if it involved Reno Stead effluent, it may be wasting money.

Mr. Smitherman confirmed this budget does not consider additional investigation into that.

Chair Hartung stated this is just a ranking and they are looking at all possible options with a study to determine feasibility.

Commissioner Brekhus discussed a previous administrative scoping on the issue.

COMMISSIONER BREKHUS MADE A MOTION TO APPROVE THE RECOMMENDED PRIORITIES FOR FY 2020-2021 WITH A PROVISION THAT IF ANY RECOMMENDATION OF PROCUREMENT OF ADDITIONAL FEASIBILITY FOR LONG VALLEY IS PROPOSED, IT COMES TO THE FULL BOARD FOR CONSIDERATION, SECONDED BY COMMISSIONER DUERR.

Chair Hartung stated he is hesitant to carve anything out and would rather give direction.

Commissioner Duerr confirmed the City of Reno ranked Long Valley Creek as the third lowest priority for disposal of effluent. She does not think it is unreasonable to ask that the information come back and does not view it as carving anything out.

Commissioner Dahir stated if it was in Sparks, he would want it to come back at least to know what's going on.

THE MOTION CARRIED UNANIMOUSLY WITH SIX (6) COMMISSIONERS PRESENT.

7. Public Hearing

a. Discussion and action on the WRWC Tentative Budget for Fiscal Year ("FY") 2020 –
 2021 and discussion and action on adoption of the WRWC Final Budget for FY 2020 –
 2021 - Chris Wessel and Jim Smitherman. (For Possible Action)

(Commissioner Weber present at 1:48 p.m.)

The WRWC is required to prepare and submit a tentative budget to the Nevada Department of Taxation on or before April 15, and to hold a public hearing on the tentative budget not sooner than the third Monday and not later than the last day in May. The staff report includes an attached tentative budget for WRWC review, discussion, adoption, and possible direction to staff. Staff recommends that the WRWC adopt and certify the WRWC Final Budget for Fiscal Year 2020–2021, and direct staff to transmit a copy to the Nevada Tax Commission, together with an affidavit of proof of publication of the notice of the public hearing.

Mr. Wessel explained for chair Hartung that he has a zero for the Stormwater GIS Mapping Project because we don't have an update from the Truckee Meadows Regional Planning Agency (TMRPA). He anticipates we will have an update at the next meeting.

Commissioner Dahir asked if any projects will be impacted by COVID-19.

Mr. Wessel stated he thinks all the projects will go forward unless something happens to TMWA's revenue stream.

COMMISSIONER BREKHUS MADE A MOTION TO ADOPT AND CERTIFY THE WRWC FINAL BUDGET FOR FISCAL YEAR 2020 – 2021, AND DIRECT STAFF TO TRANSMIT A COPY TO THE NEVADA TAX COMMISSION, TOGETHER WITH AN AFFIDAVIT OF PROOF OF PUBLICATION OF THE NOTICE OF THE PUBLIC HEARING, IN ACCORDANCE WITH LAW, SECONDED BY COMMISSIONER DAHIR. THE MOTION CARRIED UNANIMOUSLY WITH SEVEN (7) COMMISSIONERS PRESENT.
